Background

ASA 230 (Revised and Redrafted) is presented to the Board for the first time. The proposed standard is based on ISA 230 (Redrafted). ISA 230 was “redrafted” and not “revised” under the IAASB Clarity project.

ASA 230 (Revised and Redrafted) includes standardised changes in accordance with the AUASB Drafting Rules. No other changes are proposed. Changes are shown as mark-ups (Agenda Item 9(e).3).
