Background

ASA 260 (Revised and Redrafted) is presented to the Board for the third time. First read was at the April meeting. Second read was at the June meeting. The proposed standard is based on ISA 260 (Redrafted). The ISA was "Redrafted" and not revised under the IAASB Clarity project.

ASA 260 (Revised and Redrafted) includes standardised changes in accordance with the AUASB Drafting Rules. No other changes are proposed. Changes are shown as mark-ups (Agenda Item 8(c).3).
