### **Agenda Item Objectives**

To consider and approve:

- the updated communications protocols; and
- proposed amendments to the "compelling reasons test" <sup>1</sup>

#### **Background**

The AUASB and the NZAuASB held a joint meeting on 10 September 2013 where their Chairmen outlined their respective standard setting mandates. The AUASB and the NZAuASB discussed their continuing trans-Tasman co-operation in line with the Outcome Statements of their respective Governments. Particular focus was given to enhancements of communication protocols and the harmonisation of standards.

A paper, prepared by NZAuASB staff, was tabled at that meeting as Agenda Item 3. The overall focus of the paper was the enhancements of communication protocols and the harmonisation of standards. The Boards discussed various aspects of the paper and agreed to the suggested times, during the exposure and finalisation of international standards, for the two Boards to communicate.

The exact method and scope of communication, or whether the communication would be agreed to on a case by case basis was discussed and agreed. It was also agreed that the suggested communication protocols will be implemented and fine-tuned over time to ensure issues and key decisions were effectively shared on a timely basis. The Boards requested some changes to the NZAuASB staff papers – the revised papers are now presented for consideration and approval. [See Agenda Items 9d).1 and 9(d).2]
